Newsletter Highlights

Journal updates - Highlights

A systematic analysis of the global burden of chronic kidney disease (CKD) due to hypertension from 1990 to 2021 revealed that although age-standardized rates of hypertension-related CKD have declined, the absolute burden has more than doubled due to population growth and aging. Projections to 2036 indicate increasing deaths and disability-adjusted life years (DALYs), highlighting the necessity for targeted prevention and risk-factor reduction.
